If all lots you own are not paid IN FULL, you will BE SUBJECT to paying the rates as stated in Missouri Revised Statues Chapter 320 (SEE BELOW). Also check with your insurance company to see what they will cover if your Fire Tag is not fully paid, on all lots you own.
